#### President's Report

President Rao began with an update on the McGrath Award. VCU was the 2014 recipient of the award for Working Together to Transform Lives through Pharmacist Collaborative Care and Outreach in the Community (PCOC). Dr. Rao commented on the great work the pharmacy department is currently doing as well as other work going on around the university. He noted that, as an institution, we are doing more than ever with our commitment to community engagement. The award winning video was shown to members.

As we become more recognized as a University, our commitment to community engagement aligns with Quest and the final four initiatives we have to focus on, including the importance of sustainable resources. President Rao also mentioned the 40+ member budget taskforce that has been created to help shape the new budget model.

A few weeks ago the university was invited to converse with a small group of people from the Academy of Arts and Sciences. The group gathered together to talk about future of higher education. Dr. Rao felt there was more attention and interest towards VCU (which was not the same several

years ago). One message shared was that public research universities need to find a way to gain public support that we have lost.
