# President's Report:

President Rao welcomed new and returning members to the first University Council meeting of the 2014-15 academic year. Dr. John Wiencek is now interim provost following the departure of Dr. Warren for Kent State. VCU has earned several recent distinctions, including being listed as a great value college in the South because of affordability and unique learning environment, ranked a top-10 school nationally in terms of awarding PhDs to women in engineering, the freshman class is the strongest academically and most diverse in the history of the university, and VCU was named a top-10 "Hipster School." With VCU facing significant budget cuts, resources need to be reexamined to ensure the goals of Quest for Distinction are met. VCU is working to increase transparency, student financial assistance, faculty/staff compensation and physical infrastructure. The university will engage in a robust discussion about a new budget model. VCU's Title IX compliance function has been moved to the Division of Finance and Administration and more resources will be devoted to it. It will be among the strongest compliance models in America. And presidential updates to the VCU community are now being communicated via blog and social media.
